Section 4. First aid measures

Section 6. Accidental release measures

Personal precautions, protective equipment, and emergency procedures:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding area. Keep necessary and unprotected personnel from entering. Do not touch or walk-through spilled material. Put on appropriate personal protective equipment.

Methods and materials for containment and cleaning up:

Small spill: Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container.
Large spill: Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements, or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Environmental Precautions:
